



## Training Classes and Descriptions

### **DOT Safety & Compliance Essentials**

This seminar covers a the full range of all DOT regulations, including Driver Qualification, Hours of Service, CSA and Vehicle Requirements. Applicable for Safety Managers and Administration.

### **Hours of Service/ELD Compliance**

This seminar covers Hours of Service regulations, Log Books/Time Card requirements and how to audit your drivers. Covers ELD's and compliance. Applicable for Safety Managers, Mechanics and Drivers.

### **DataQ's Seminar**

The what, why and how to successfully challenge incorrect roadside inspection violations or crash information with the DataQ's process. Applicable for Safety Managers.

### **Surviving DOT Audits**

This seminar covers the various types of investigations (compliance reviews, audits, interventions) and how to prepare for them. Also includes how to respond to Notices of Violation and/or Claim. Applicable for Safety Managers and Administrative Staff.

### **DOT Files and Recordkeeping**

This seminar covers specific paperwork requirements for driver qualification, driver history, drug/alcohol and vehicle maintenance files. Applicable for Safety Managers and Administrative Staffs.

### **Annual Vehicle Inspection/Appendix G Seminar**

This seminar covers the elements of the DOT Annual Vehicle Inspection, taught by a former CO State Patrol Inspector. Learn how to correctly perform an Annual Vehicle Inspection and discover Appendix G. Applicable for Safety Managers and mechanics.

### **Brake Certification**

This hands-on seminar covers how to adjust and manipulate brakes and brake systems. Includes video training. Applicable for Safety Managers, Mechanics and Drivers.

### **Cargo Securement**

This course is designed to provide instruction of the use of various types of Cargo Securement used by the industry in the shipment of materials, machines, equipment,

dunnage and miscellaneous items. Applicable for company personnel utilizing pickups with trailers or 1 ton pickups all the way up to semi tractors and trailers.

**Drug/Alcohol Policies and Procedures Seminar**

This seminar covers general policies and requirements for alcohol and controlled substance programs as required by DOT. CFR Parts 40 and 382. Applicable for Safety Managers.

**Drug/Alcohol Reasonable Suspicion Seminar**

This seminar covers required training for Supervisors with Drug/Alcohol programs in their companies. CFR Parts 40 and 382. Applicable for Safety Managers.

**Designated Employer Representative Seminar**

This seminar covers the responsibilities of the Designated Employer Representative for motor carrier companies. You are required by DOT to have a DER in your company. Applicable for Safety Managers and Administration.

**NATMI – Fleet Safety Certification Courses**

**Motor Fleet Safety Basics** – this 2-day “Fleet Safety 101” program is designed to provide training on effective implementation of safety-related policies and procedures. This course is designed for line-level safety supervisors with emphasis on what they need to do and when and how to do it.

**Managing Motor Fleet Safety Programs** – this 2-day course is designed to provide transportation safety directors and prospective safety directors with the vision and skills that they need to manage an effective safety program. This course is designed with role-playing and case-based scenarios.

**Certification Exam** – this 1-day is the certification exam for CSS (Supervisor) or CDS (Director). In addition to the course work, job experience is required.
