Subject: COVID-19 Emergency Waiver

To: IRP Inc., IRP Member Jurisdictions and Law Enforcement

Effective March 10, 2020, the State of Colorado is in a state of emergency due to the COVID-19 virus. In response, the State of Colorado is waiving registration late fees, providing registration extensions, and issuing weight exemptions.

IRP Registrations

On March 18, 2020 all Colorado DMV offices were directed to be closed to the public until April 18. During this restricted customer access, DMV staff has continued to work internally, supporting online, mail, and phones. Additionally, effective May 6th, limited IRP appointments are available; please visit https://www.colorado.gov/pacific/dmv/commercial-vehicles for more information.

During this time, registration late fees were waived and registration extensions allowed with no penalties. At this time, county and state offices are processing registrations and no new registration extension letters are being provided. Late fees are being waived until June 30, 2020. Until that time, jurisdictions should not cite these vehicles. As previously mentioned, online and mail-in services are available, as well as limited appointments. There may be a delay in normal processing times. Customer service representatives will be available via phone and email during normal hours of operation. IFTA Carriers

The Denver Taxpayer Service Center at 1375 Sherman St is closing and will be moving to 1881 Pierce St in Lakewood. It will open to the public on a limited basis by appointment only on June 15th. The IFTA staff will NOT be available for walk-in service at the Lakewood location when it opens. CDOT

The Governor issued an Executive Order that will allow all tractor-trailer combinations to operate on all state roads and the interstates at 85,000 pound gross weight. Other states have increased their interstate weights to 90,000-100,000 pounds, but CDOT has worked closely with CSP and industry representatives and we believe 85,000 pounds is the appropriate number at this time. This exemption will continue through the Governor's declared emergency.

CDOT is considering exempting Longer Vehicle Combinations from complying with the time restrictions in the metropolitan areas. LVCs currently cannot operate from 7am-9am and from 4pm-6pm M-F on routes in Denver, Colorado Springs, and Pueblo. This <u>map</u> details these restrictions. This exemption expires July 30th, 2020.
